Minutes of the General Membership Meeting September 4, 2007

Call to Order

Pat Rosenthal called the meeting to order at 7:05 PM. 11 members and 5 visitors were present.

Approval of Minutes

A motion was made and unanimously carried to approve the minutes of the 8/7/2007 meeting with the following changes to the Publicity Committee section:

- o The Downtown Festival is scheduled for 9/15.
- The Friends did acquire a new couple memberships at the Festival in 2006.

Guest Speaker

Naman Shah, Eagle Scout candidate from Troop 18, gave an update on his project to build and place bat boxes and tree sparrow boxes along the trail:

- o Naman built the bat and sparrow boxes.
- He has collected \$215 of the \$600 that he needs to complete the project. A motion was made and unanimously carried to match each dollar that Naman raises with a dollar contribution from the Friends, up to a maximum of \$300 in matching funds. Naman can contact Dave when ready to receive the funds.
- o Naman reported that Joe Arcudi can provide a bucket truck for the installation.
- o It was agreed to leave it to Naman to select locations. Reno suggested off the grass and behind fences as not to interfere with trail maintenance and to lessen the opportunity for vandalism.

• <u>Trail Committee Report – Reno DeLuzio</u>

- O The Mass Highway public hearing on Phase 2 is scheduled for 9/19 at 7 PM at the Milford High School Cafeteria. In Phase 1, a concerted effort was made to get as much public support as possible at the public hearing. This project is competing for funds with projects from other towns. We are looking for \$4 million for Phase 2. Reno is contacting civic organizations to promote attendance at the public hearing and asking us to do the same thing. We will also send an email to the Friends membership and put a notice on the Friends website, adding detail from the flyer Reno passed out.
- Proposed 2 fully activated signal crossings. Need to do Phase 1 counts to justify building signal crossings. A regional planning person from Boston is organizing the count. We will do the count from 7 AM to 7 PM on Saturday 9/8. There will be one station at Louisa Lake and one at Fino Field trail intersection. An instructional meeting will be at Town Hall Room 14 on Wednesday 9/5 at 7:15 PM.
