Friends of the Milford Upper Charles Trail Treasurer Report January 8, 2007

- Since last meeting:
 - o Completed treasurer position transition from Dave
 - o Added check-writing authority for two officers to the bank account
 - Entered the bank statements into Quicken from account inception in 2005 through current statement.
 - o Completed the 2007 financial statement.
- Summary of 2007 Financial Statement:
 - Opening balance of about \$4000 and closing balance of about \$12,000 dollars, for a net gain of about \$8000. The net gain comes from about \$20,000 in income minus about \$12,000 in expenses.
 - o Income of about \$20,000:
 - 85% of this from donations or grants from the Harmon Foundation, businesses, and the town.
 - The remaining 15% was from membership fees, grand opening vendor registration fees, and t-shirt sales.
 - Expenses of about \$12,000:
 - Largest category is granite benches at about \$5,500.
 - Next is nearly \$4000 for the Grand Opening.
 - About \$1300 for doggie stations and bags.
 - About \$1200 for insurance.
 - Will send copy of 2007 Financial Statement to the Secretary for inclusion in the minutes of the meeting.
- Outstanding financial commitments: None
- Known regular expenses due in 2008
 - o Directors & Officers insurance, if renewed. \$804 in 2007
 - o Liability insurance, if renewed. \$364 in 2007
- Actions to be completed:
 - Create form to be completed for each disbursement for
 - Referencing motion authorizing expenditure
 - Attaching receipt(s)
 - O Determine what forms must be filled out for the IRS by the next meeting, and possibly complete them by then.

Committee Reports

- Town of Milford Trail Committee Reno Deluzio
 - Reno was speaking to the Bruce Freeman Trail group tonight and unable to attend our meeting.

- Fundraising and Membership Committee Barbara Bradbury and Tony Niro
 - o Barbara has received one more request to do a memorial bench. She told the person that we would do the installation in the spring.
 - There is one authorized bench left as well as the wooden benches to come from Mark Fitzpatrick.
 - She thought it would be worthwhile to do some publicity regarding the availability of "memorial" benches
- Maintenance and Enhancement Dave Cassinelli and Sheldon Moniz
 - o A new Master Plan and Adopt a Trail has been developed
 - An additional kiosk will be built and placed at the trail head by the Commuter parking lot. This will be done as an Eagle Scout project by Spencer Carlin who will purchase the wood that Chris Chamberlin was going to use. Spencer will present his project at the February meeting.
- Education and Special Activities
 - o Chair vacant (filled during new business)

Old Business

- Pat made a request for approval for an additional \$49.30 to cover cost of the 11 plaques produced to date. There was a motion to approve and it passed unanimously.
- A motion was also made and approved to spend up to \$50.00 to correct the Critter Visits plaque which initially had an incorrect name on it.

New Business

- Pat appointed Linda Konvalinka and Christine Haslam as co-chairs for the Education and Special Events Committee. The appointment was approved by the general membership.
 - o Linda and Christine suggested organizing a night hike on January 22nd called the Full Moon Walk. The walk will start at 7:00 pm at Louisa Lake and proceed to Wendy's and then return. Publicity for the event will be done to the general email list, on Christine Taddei's web site, on our own web site and in the paper.
 - Linda also suggested a February night hike to listen for owls and a Bird and Bathouse family walk led by Naman Shah in the spring.
- Pat appointed Julie Rosenthal to act as Media Liaison. The appointment was approved by the general membership. Julie will be responsible for press releases to publicize the activities of the Friends.

- Pat presented information regarding the upcoming Family Network Project Fun Fair to be held at the high school on March 15 from 11-2. It was agreed that this would be a good awareness building activity and potential membership drive for the Friends. Christine Haslam, Margaret Myatt, Dave Cassinelli and John Edmondson agreed to staff the event.
- Pat reminded the members that there is a Pedestrian Survey on our web site and encouraged all to take it as it influences the distribution and allocation of funds.
- It was agreed that we should re-invite the Firefighters who have contacted us regarding mile markers on the trail.
- There was some discussion regarding whether signage belongs under the
 Maintenance and Enhancement group or Education and Special Activities. But it
 was agreed that as currently stated on the trail the traffic pattern is incorrect.
 Walkers should walk facing bike traffic and not in the same direction. This could
 be added to our web site.
- Christine Taddei questioned the locking of the gates at Louisa Lake and the
 possibility that emergency vehicles could not get in and that police were not
 patrolling due to this. John Edmondson agreed to follow up with the police
 department.
- Linda Konvalinka would like to develop an educational project regarding invasive species along the trail.
