• Dave Cassinelli-Maintenance and Enhancement

- Dave will contact Cub Scouts to see if they will build a back-up supply of birdhouses to replace damaged ones.
- O Dave will contact Mike Bresciani regarding fencing that needs to be replaced at Huckleberry Brook and at the Dilla St. damn.
- The weeds behind Benjamin Moore have been cut back but continue to be a threat to the integrity of the asphalt.

Christine Haslam-Education and Activities

- o Has quotes for Dog Officer vests. After discussion it was decided to get 2 of them.

- O Planning membership BBQ for late summer. Est. 100 people if we send invitations to members and their families. An RSVP format will be used. Marie Clemente offered support in purchasing food and will allow us to use the parking lot at Midtown Family Fitness.
- Membership and Fundraising-Margaret Myatt and Susan Edmondson
 - Chair people were absent but Marie Clemente was thanked for recruiting 5 new members last month. She is also planning a "Spinathon" at the club to raise funds and membership.

New Business

- Officer elections will be held in September. Pat is retiring from Presidency; the other three officers (Vice-President, Secretary, and Treasurer) will stay on for one more 2 year term if they are nominated and elected at the general meeting. We will also need to elect a new director to replace Tony Niro who has resigned. Tony has been invaluable in his support for the trail but finds that family and business obligations no longer allow him to devote his time.
- Reno DeLuzio expressed support for the suggestion that we find an "Historian" to document the development of the trail. He also feels that our website is stale and needs new energy and better input on current events, particularly with the start of phase 2 construction. Ted Hayes has offered to help with photography for the trail, but we need a reporter.
- Reno also noted that the condition of the 2 downtown trailheads was very shabby. Alternatives has been waiting for the kiosk to go in, and the Italian Vets are just getting started on their portion. Things will be progressing in the next couple of weeks.

 - o Up to \$230.00 to reimburse without receipts for the 2009 Easter Egg Hunt [09-17]
 - o Close the authorization for \$100.00 for the 2010 Easter Egg Hunt [09-18]
