Committee Reports

- Dave Cassinelli-Maintenance and Enhancements
 - A completed application to become an Adopt a Trail partner was received from Hockomock YMCA and they were approved to maintain the trail section beginning at the Dilla Street/Louisa Lake parking lot and ending at the first asphalt turnout.
 - There is a puddle that forms after rain on the section near the Dauphinee bench. Also, a problem with erosion on some banks that are currently just dirt, and being used by mountain bikers as "ramps". It was suggested that some fencing and planting of ground cover might help.
 - The fall clean-up is scheduled for Oct. 17 from 9-12. Rain date is Oct. 24th.
 Boston Cares will be coming to help out. We need trimmers, weed wackers, edgers, blowers and coal shovels.
 - Dave will talk to Mike Bresciani about the Friends buying an edger for the Parks Department. Reno suggested that they pick it out.
 - Our Adopt a Trail partners need to be reminded of their obligations. There are inspection report forms available online at our website.
 - Will Roper will do eWaste collection at the Mason's craft fair on Oct. 4th and wants to do another one at our cleanup day on the 17th. Committee feels he should wait for spring cleanup.
 - A motion was made to move the eWaste collection to our spring cleanup.

 - There are no activities scheduled at this time.
