## **Guest Presentations**

- Laurie Sweet spoke to the group about possible fundraising ideas to use if we decide to pursue
  the Guiness World Book Record for the longest hopscotch. Various dates and the types of
  materials to be used were also discussed. Details will be discussed at the Board of Directors
  meeting on April 17.
- Reno DeLuzio reported:
  - 1. -that tThere were was serious flooding problems of several homes at the end of Pond Street downtown-due to the heavy rains and the contractor's failure to maintain existing drainage along the Senior Center Spur. In addition the heavy rains exposed and also higher than anticipated ground water levels along approximately 540 feet of trail easterly of Rte. 85.-portion: which will require design changes to install sub-drains.
  - The Trail Committee is working on a plan to develop an interim path for the Phase 3 missing link to be constructed with mostly pro-bono participation. Rough estimates put the cost of the interim path at around will require about \$400,000 if the Town were to go out to bid. of additional funding.
  - 3. At a recent budget meeting of Tthe Parks and Highway Departments met with the Finance committee and the issue of trail maintenance responsibility and costs came up there are serious budget issues. Reno stated that the Friends can no longer be the a bystander and has to take the lead in getting the Friends, Parks Department, and Highway Departments to come to a consensus on maintenance responsibilities, process, costs, and funding sources.; we have to get involved and have a voice. He will arrange a meeting with Dave Cassinelli, Mike Bresciani of the Parks Dept.\_and Scott Crisafulli of the Highway Dept.\_
- Sgt. Sanchioni said there have been some unleashed dog issues but no serious problems
  reported. He is still working on the helmets. He had received a letter requesting size
  requirements so feels this is a good sign. He also suggested a little better supervision along the
  trail during the Easter Egg Hunt to keep children away from the water and Dilla St.

Dave will talk to Mike Bresciani to see if he has any objections, and Reno suggested that if we allow it we specify that we have final say as to materials and design.
- Pat will get materials to represent the trail at a Transportation Booth during an Earth Day function at EMC. Theresa volunteered to assist her with this. They will use brochures and the map.
- Mr. Nargi asked permission to put a small fence by his bench to protect some flowers; this was approved.
- There was a motion made and accepted to reimburse Dave \$58.44 for the rental of a costume for the egg hunt. The entire \$350.00 previously approved had been spent on candy.
- There was a motion made and accepted to reimburse Tom Myatt in the amount of \$74.00. This was the cost of filing with the Secretary of State in the amount of \$18.50 for four years.
