That area is part of the YMCA Adopt a Trail section. They also brought up the fact that a better definition of where benches are could be provided. - Reno DeLuzio had attended a conference on Grants from the DCR (Dept. of Conservation and Recreation). He thought perhaps next year we could look into getting some funding here to address the accessibility issues. Phase 2 is going well. Phase 3 has a cost estimate of \$400,000 for engineering and \$21,000 for Environmental Permitting. He asked for support for his presentation at the Oct. 25th Town Meeting.
